Dear Sirs,

This day following agreement has been made with QUEENS RADIO & TELEVISION CORPORATION, 796 & 861. Alutmawatte Road, P.O. Box 637, Colombo 15, Ceylon, according to which agreement A/S S.P. Radio, Aalborg, Denmark, appoint Queens Radio & Television Corporation their general agents for Ceylon for any marine radio equipment produced by A/S S.P. Radio. A/S S.P. Radio bind themselves, under no circumstances to deliver marine radio equipment to other firms or persons in Ceylon but Queens Radio & Television Corporation. In the same way A/S S.P. Radio bind themselves to hand over to Queens Radio & Television Corporation any inquiry and other correspondence that might be received from Ceylon regarding radio equipment.

Guarantee obligations: A/S S.P. Radio offer 6 months guarantee on all components, which may become defective from general use. In case of violence no guarantee is offered. The expenses in connection with the replacement of defective parts, such as freight, wages etc. will not be covered by A/S S.P. Radio.

Advertising: A/S S.P. Radio will free of charge deliver brochures to a reasonable extent. In the same way A/S S.P. Radio will place printing blocks at Queens Radio & Television Corporation's disposal, if it is wanted.

Queens Radio & Television Corporation will under no circumstances be allowed to deliver A/S S.P. Radio's products outside Ceylon.

Queens Radio & Television Corporation engage themselves through advertisements and attendance at exhibitions to a reasonable extent

to keep the public informed of what products A/S S.P. Radio are producing.

Queens Radio & Television Corporation bind themselves, at any time to keep A/S S.P. Radio informed of the selling prices of A/S S.P. Radio's products.

Terms of payment: Irrevocable letter of credit.

As a confirmation of the agreement Queens Radio & Television Corporation will return a specimen of this agreement duly signed. A/S S.P. Radio's engagements will take effect from 1st October, 1968.


This agreement will be valid for one year, after which time it will be prolonged for one year at a time, if it is not cancelled by one of the parties with at least 3 months' notice before the expiration of a calendar year. Both parties are entitled to cancel the agreement.
